

NOTICE OF GENERAL ELECTION

Notice is hereby given that on **Tuesday the 6th day of November, 2018**, a statewide General Election will be held in Nebraska. The polling place for the three Valentine precincts will be the **4-H Building at the Cherry County Fairgrounds, with the polls to open at 8:00 AM and close at 8:00 PM Central Time**. Registered voters in all other precincts in Cherry County will receive their ballots through the mail approximately 20 days prior to the election. Return envelopes, with postage included, will be provided. The General Election will be for electing candidates to various offices. Some races will not appear on your ballot as the candidates are elected by specific subdivisions, districts or wards.

The Secretary of State will publish a true copy of the title and text of any amendments or referendums once each week for three consecutive weeks preceding the election in accordance with **§49-202**.
