BOARD OF COMMISSIONERS MINUTES May 9, 2017

The Cherry County Board of Commissioners met in regular session on May 9, 2017 at 10:00 AM, as per notice in the Valentine Midland News, with the agenda being on file in the office of the County Clerk. Roll call was taken. Present at this meeting were Cherry County Commissioners: Jim Van Winkle, Tanya Storer, and Martin DeNaeyer and Cherry County Clerk, Tom Elliott. Also present were Carolyn Semin and Twyla Witt.

The meeting was called to order at 10:00 AM by Chairman Storer. The Open Meetings Act Notice was announced and the Pledge of Allegiance was recited. The minutes of the last regular meeting were read. Commissioner Storer moved to approve the minutes as read. Commissioner Van Winkle seconded the motion. Roll call vote was taken. Commissioner DeNaeyer-aye. Commissioner Van Winkle-aye. Commissioner Storer-aye. The motion carried.

The minutes from the April 25, 2017 Board of Corrections meeting were read. Commissioner DeNaeyer moved to approve the minutes as read. Commissioner Van Winkle seconded the motion. Roll call vote was taken. Commissioner Storer-aye. Commissioner Van Winkle-aye. Commissioner DeNaeyer-aye. The motion carried.

Cyrus Wolfenden addressed the Board to discuss a proposed road project near his home that would require moving an existing culvert and constructing a portion of new road. The project has been under consideration for a period of time. It was the consensus of the Board to contact the County Surveyor and the District 2 Road Foreman to discuss the required Corps of Engineer permits and landowner easements for the area before moving forward with the project.

The Board discussed the need to fill a vacancy on the County Board of Adjustments.

Commissioner DeNaeyer moved to appoint Michael McLeod to the Cherry County Board of Adjustments to a term to expire January 11, 2020. Commissioner Vane Winkle seconded the motion. Roll call vote was taken. Commissioner Van Winkle-aye. Commissioner DeNaeyer-aye. Commissioner Storer-abstain. The motion carried.

Larry Burbach with Nebraska Machinery discussed a maintenance issue on a motor grader. No Board action was required.

The Board reviewed the fee report from the Clerk of the District Court for the month of April.

The Board reviewed the April bank reconciliations for the Imprest Account and the Health Accounts.

No public comments were received.

The Board made a quarterly inspection of the jail. No major issues were observed.
