



## BOARD OF COMMISSIONERS MINUTES November 28, 2017

The Cherry County Board of Commissioners met in regular session on November 28, 2017 at 10:00 AM, as per notice in the Valentine Midland News, with the agenda being on file in the office of the County Clerk. Roll call was taken. Present at this meeting were Cherry County Commissioners Tanya Storer, Jim Van Winkle, Martin DeNaeyer, and Cherry County Clerk Tom Elliott. Also present were Merrial Rhoades and Carolyn Semin.

The meeting was called to order at 10:00 AM by Chairman Storer. The Open Meetings Act Poster was acknowledged by Chairman Storer and the Pledge of Allegiance was recited. The minutes of the last regular meeting were read. Commissioner Van Winkle moved to approve as read. Commissioner DeNaeyer seconded the motion. Roll call vote was taken. Commissioner Storer-aye. Commissioner DeNaeyer-aye. Commissioner Van Winkle-aye. The motion carried.

The minutes from the November 14, 2017 Board of Corrections meeting were read. Commissioner DeNaeyer moved to approve the minutes as read. Commissioner Storer seconded the motion. Roll call vote was taken. Commissioner Van Winkle-aye. Commissioner Storer-aye. Commissioner DeNaeyer-aye. The motion carried.

Cherry County Assessor, Betty Daugherty, addressed the Board regarding a draft of projected agland valuation statistics for 2018 based on 2017 values. Mrs. Daugherty also presented some tax list corrections that resulted from a computer malfunction.

Commissioner Van Winkle moved to approve seven current tax list corrections for a total adjustment of \$35.04, as presented by the County Assessor. Commissioner DeNaeyer seconded the motion. Roll call vote was taken. Commissioner Storer-aye. Commissioner Van Winkle-aye. Commissioner DeNaeyer-aye. The motion carried.

Commissioner Storer moved to approve the claims, with a correction to be made for one employee, with the correction to be made at the next regular pay period. The motion was seconded by Commissioner Van Winkle. Roll call vote was taken. Commissioner DeNaeyer-aye. Commissioner Storer-aye. Commissioner Van Winkle-aye. The motion carried.

Also present for the afternoon portion of the meeting were Charlene Reiser-McCormick, Twyla Yeager, Ann Warren, Mike Burge, Dave Hamilton and Michael Knapp.

At public comment time Jim Ducey inquired about pending zoning permit applications. Mike Burge inquired about the protocol for the Planning Commission providing recommendations to the Board, as voted upon following a Planning Commission public hearing.

In the absence of the Zoning Administrator, it was the consensus of the Board to contact the County Attorney and the Chairman of the Planning Commission to determine the best way to meet the current needs of the office.

The Board discussed the lease scheduled to expire in December for the skid steer used for snow removal at the Courthouse. Several informal bids were reviewed.

Commissioner Van Winkle moved to approve a rental agreement with Titan Machinery for a Bobcat T650 track loader for a one-year term at the cost of \$4,850.00. The motion was seconded by Commissioner Storer. Roll call vote was taken. Commissioner DeNaeyer-aye. Commissioner Van Winkle-aye. Commissioner Storer-aye. The motion carried.

At 2:05 PM, it was the consensus of the board to temporarily move the meeting to the Courtroom to accommodate a remote presentation via the internet on the subject of sound and infrasound from wind turbines. The presentation was introduced by Matt Robinette, Vice President of Development for Bluestem Energy Solutions. The presenter was Ryan Callahan from Epsilon Associates, Inc. Following the presentation, Mr. Callahan answered a few questions from the Board.

The meeting returned to the regular Commissioner Meeting room at 2:45 PM.

At 3:00 PM, as advertised, the Board recessed from regular session to convene as a Board of Corrections.

At 3:10 PM, the Board returned to regular session.
