Notice to Non-Partisan Voters

A registered voter who is not affiliated with a political party who desires to vote in the Primary Election for the office of United States Senator and/or United States Representative may request a partisan primary ballot for any one of the State Recognized Political Parties.

No such registered voter shall receive more than one such partisan ballot.

Dear Cherry County Voter,

You are receiving this letter because your current voter registration reflects no party affiliation (Nonpartisan). Due to the Nebraska Closed Primary System, Nebraska law allows for you to request to vote on one of the other Nebraska-Recognized Parties Ballot types listed on the Nonpartisan/Partisan Ballot Application which is also enclosed with this letter.

The Cherry County Clerk's Office will be mailing ballots for the 2022 Primary Election on April 20, 2022.
