INSTRUCTIONS TO VOTER

The following are instructions on how to vote your ballot. Please follow these instructions precisely, otherwise, your ballot may not be counted.

- 1. Verify that there are initials of an election official at the bottom of the ballot.
2. Verify that there are no voting marks on the ballot.
3. Use a #2 pencil or black or blue ink pen to mark the ballot.
4. TO VOTE, you must darken the oval completely (●). Placing other marks outside the oval will not suffice.
5. Do NOT cross out or erase. If you make a mistake, contact the Cherry County Clerk's Office at (402)-376-2771 for instructions.
6. Do NOT overvote or your ballot will not be counted.
7. Place voted ballot into return identification envelope (brown) and complete, SIGN, and seal envelope. Any person physically unable to sign the envelope must make his/her "mark" and must have an individual witness.
8. Do NOT place more than ONE (1) voted ballot into the return identification envelope.
Failure to complete and sign the Return Identification Envelope (brown) will cause the ballot to be rejected.
9. Return Ballot By:
a. Hand Delivery - deliver the ballot to the office of the County Clerk, located at 365 N Main St. Valentine, NE 69201.
b. Mail - return ballot by mail with return postage that has been provided.
c. Dropbox - outside the courthouse by the Treasurer's Office doors.
10. Ballot MUST be in possession of the Cherry County Clerk by 5:00 p.m. on February 9, 2021, regardless of postmark date, in order to be counted.

SCHOOL BOND ELECTION - CHERRY COUNTY SCHOOL DISTRICT 0030 (CODY-KILGORE UNIFIED SCHOOLS) IN THE STATE OF NEBRASKA

"Shall Cherry County School District 0030 (Cody-Kilgore Unified Schools), in the State of Nebraska, issue the bonds of said District in the principal amount of not to exceed Six Million Five Hundred Thousand Dollars (\$6,500,000) for the purpose of paying the costs of constructing additions to and renovations of the existing high school building and providing for necessary furniture and apparatus for such school buildings and additions; said bonds to be issued from time to time as may be determined by the Board of Education, to bear interest at a rate or rates to be determined by the Board of Education and to become due at such time or times as may be fixed by the Board of Education; and

"Shall the District cause to be levied and collected annually a special levy of taxes against all the taxable property in said District sufficient in rate and amount to pay the interest and principal of said bonds as the same become due?"

- FOR said bonds and tax
AGAINST said bonds and tax

Electors voting in favor of said proposition shall blacken completely the oval opposite the words "FOR said bonds and tax" following said proposition, and electors voting against said proposition shall blacken completely the oval opposite the words "AGAINST said bonds and tax" following said proposition.
